STATUS OF CONFEDERATE ICONOGRAPHY ON POST

Commemorations and Memorials Naming and Review Committee April 2022

Pursuant to the charges issued upon its formation in October 2020, the Commemorations and Memorials Naming and Review Committee, an ad-hoc committee of the VMI Board of Visitors, has reviewed all artwork, memorials, commemorative items, and names on Post that have associations with the Confederacy. These tributes were collected in an Inventory approved by the Board of Visitors on 29 January 2021. Based on the directives set forth in the document "Finding Meaning in the Landscape and Criteria by Which to Assess it," also adopted by the Board of Visitors on 29 January 2021, the committee has been engaged in thorough, thoughtful deliberation on the appropriateness of each item relative to the ultimate goal of fostering a welcoming and inspirational landscape on Post for cadets, faculty, staff, and visitors. In connection with the analysis undertaken by the committee, the committee looked at the purpose of the veneration of each item. If the purpose of the tribute was the veneration of the person as a confederate soldier or the confederacy generally or slavery generally, the item was removed. Alternatively, if the purpose behind the tribute was to venerate the person's contribution to VMI, and if that contribution outweighed the compelling historical considerations, the item was retained.

In determining the most appropriate course of action to recommend for an individual item, the committee considered three possible options:

- Remain "as is" the item should stay as it currently is;
- Retain & Explain the item should be retained by VMI, but may be moved to a different location on Post, may have appropriate contextualizing information made available, and/or may have current text revised; or
- Remove the item should no longer remain on Post or should be renamed

The table below—with reference to the Inventory page number—represents a summary of the committee's recommendations to the full Board of Visitors. In addition, the table sets forth any action taken by the BOV and the current status of the object.
