

2023-2024 Independent Verification 1 Worksheet Federal Student Aid Programs

- 2. Independent students who are **NON-Tax Filers** need to complete IRS Form <u>4506-T</u> to receive a "Verification of NON-Filing" letter" and submit letter to our office. Please call IRS at 1-800-908-9946 with any questions.
- 3. Please use <u>IRS Data Retrieval Tool (DRT)</u> on your FAFSA or submit **Tax Return Transcript** for 2021 (IRS Form 1040, 1040A or 1040ez are <u>not</u> sufficient), and any other documents requested, to our office.
- 4. We will compare the information on these documents to your FAFSA and make corrections if necessary.
